



LETTER FROM THE CHAIRMAN

2021 marked the 25th anniversary of the InfraGard program. This historical milestone represents a joint accomplishment of numerous stakeholders who have contributed to the safety and security of our nation, including: our 80,000+InfraGard members; our InfraGard Members Alliance (IMA) leaders; our InfraGard National Members Alliance (INMA) board, staff and representatives; our FBI partners; and supporters. Their collective talent, dedication and service has enabled us to fulfill one of the most worthwhile missions in the world: protecting U.S. critical infrastructure and the American people.

In 1996, the FBI Cleveland Field Office enlisted the help of the private sector in solving a cybercrime case. Consequently, the emergence has been gradual for our local InfraGard chapters, but it has been characterized by resilience, care and concern for colleagues, and a commitment to creating positive outcomes for the members we serve. When it comes to collaboration and information sharing, there is no substitute for getting together in person and we expect that trend to continue in the safest manner possible.

To acknowledge the city where the foundation was laid for the InfraGard program, we proudly held this year's InfraGard Congress in Cleveland. The National Cross-Sector Council (CSC) Program also continued to grow, with seven CSCs working hard to provide valuable programs across multiple critical infrastructure sectors. The National Disaster Resilience Council held its annual Summit virtually, focusing on preparedness for both attacks and destructive natural events causing long-term outages of U.S. critical infrastructure.

Our National Sector Security and Resilience Program (NSSRP) completed multiple rounds of leadership appointments, bringing our new total to 13 National Sector Chiefs and 26 subject matter experts. From chapter meetings to fireside chats, these webinars were well attended and highly successful. We cannot thank our chapter leaders enough for their stellar contributions.

Program Overview: Training and education is integral to the InfraGard National Members Alliance mission and the InfraGard program. National Sector Security and Resilience Program (NSSRP)

Program Manager: Daniel Honore, INMA Board Member, InfraGard Wisconsin, (August 2021 – present)

Past Program Chair: Christine Karlson, InfraGard Huntsville, (January - August 2021)

Program Overview: The National Sector Security and Resiliency Program (NSSRP) is intended to strengthen national critical infrastructure security and resilience. The NSSRP contributes to the InfraGard mission through the creation and sustainment of a "network-of-networks" to foster collaboration and information sharing among and between owners, operators, and participants of critical infrastructure within individual sectors.

The NSSRP has the following objectives:

- Recruitment of all CI owners and operators pertinent to the local IMA;
- Provision of education and training that meets the needs of CI owners and operators;
- Enablement of intra/inter-sector networking opportunities for CI owners and operators; and
- Timely, accurate, and actionable two-way information sharing.

National Highlights and Key Activities from 2020 - 2021

- The Program Chairs completed multiple rounds of National Sector Chief and Subject Matter Expert appointments. There are 13 National Sector Chiefs and 26 Subject Matter Experts. Only three National Sector Chief seats remained vacant in 2021.
- On February 17, 2021, a National Sector Security and Resiliency Program webinar was held to reintroduce
 the NSSRP program to IMA leaders. The agenda included the hallmarks of strong sector programs, how to
 build and sustain effective sector program in local areas of responsibility, and how to build participation.
 Over 100 people attended this virtual event.
- A new NSSRP Sector Chief Training Academy (SCTA) program was initiated to provide education and training
 on what makes for a strong sector program. Our goal is to train current and new Sector Chiefs, Sector Chief
 Coordinators, and other IMA leaders about the program, its value, and how to build a strong Sector Security
 and Resiliency Program at the grassroots level. The SCTA also establishes resources and training to assist
 Sector Chiefs in creating and refining a team project or deliverable for real-world execution within their
 respective InfraGard chapters and areas of responsibility.
- In August 2021, Mr. Daniel Honore was appointed as the Program Manager of the National Sector Security and Resiliency Program. Mr. Honore serves on the board of directors of InfraGard National Members Alliance and is President Emeritus of InfraGard Wisconsin.
- The NSSRP section within the FBI InfraGard Portal was updated to include the following critical infrastructure sectors: Chemical, Critical Manufacturing, Dams, Government Facilities, and Nuclear Reactors, Materials and Waste. All 16 critical infrastructure sectors are now represented.

Sector-Specific Highlights and Key Activities from 2020 - 2021

Energy Sector | National Sector Chief KC Carnes

- Worked with InfraGard New York Metro and InfraGard New Jersey on developing partnerships and engaging the sector.
- Discussions are ongoing with the Oil and Natural Gas Sector Coordinating Council (ONGSCC) vice chair on broadening the definition of energy to include the entire sector beyond electricity. Planning is ongoing to take follow-up items to the ONGSCC meeting to encourage ONG exploration (wells and drilling platforms) to transmission (midstream pipelines), distribution (gas utilities, propane distributors, etc.), and consumer services (such as fueling stations) to engage with local InfraGard chapters and volunteer as local Sector Chiefs. In addition, discussions are taking place about future opportunities for an educational discussion for cross-sector or Energy Sector Chiefs to better understand the non- electrical side of the energy mix.

Defense Industrial Base | National Sector Chief Jim Lint

- Participated in InfraGard National Disaster Resilience Council (NDRC) weekly conference calls to discuss the risks and impacts from COVID-19. Gained information to pass to the local DIB Sector Chiefs and DIB Forums.
- Participated as a panelist in the February 17 National Sector Security & Resiliency Program (NSSRP) Webinar hosted by InfraGard National Members Alliance.
- Participated in the Solar Sunburst Webinar, which was also attended by DIB Chapter Sector Chiefs.
- Attended the Joint National Defense Industry Association (Southwest) and InfraGard webinar about Cybersecurity Maturity Model Certification (CMMC) and its current status in the Defense Industrial Base.

Emergency Services | National Sector Chief Rob Yandow

- Began the process to develop a culture of preparedness in the Emergency Services Sector by promoting
 preparedness information for all critical infrastructure sectors pursuant to our mission, as outlined by the
 Cybersecurity and Infrastructure Security Agency (CISA).
- Held a virtual Sector Chief planning meeting to discuss future plans for the sector.

Financial Services | National Sector Chief Denyette DePierro

- Continued to hold a monthly Financial Services Sector call with the local IMA Financial Services Sector Chiefs.
- Developed channels and best practices for cross-marketing and cross-promoting events, meetings and webinars hosted by other Financial Services Sector Chiefs.
- Moderated a webinar with the CEO of the Financial Services ISAC on Third Party Risk Management, titled "It's
 Not Just About You: Third Party and Supply Risk in Financial Services: What Can We Learn from SolarWinds,
 Microsoft, and Colonial Pipeline?" Co-hosted with InfraGard NCR on May 19 and had 140 participants.

 and Analysis Unit at FBI HQ to draft an informational sheet that captures inputs from the Transportation
 Sector's participation in the EIS Council's 2020 EARTH EX V global exercise. The 2020 event focused on
 EMP and large- scale cyber-attack scenarios. The 2020 effort opened the door to future work with the EIS

 September/October 2021.
- The Cross-Sector Council for Blockchain Applications in Transportation is now up and running. Participated
 on the Board to help make this initiative a positive resource for transportation professionals.
- Attended InfraGard Northern Ohio's webinar, Autonomously Changing the Driving World, on June 4. This event was organized by the NOC Transportation Sector Chief and provided insight into the DriveOhio and FlyOhio advanced transportation initiatives. The event also featured input from the Auto ISAC and Surface Transportation ISAC.

National Disaster Resilience Council (NDRC)

Chair: Mary Lasky, (InfraGard Maryland)

Vice Chair: Steve Volandt, (InfraGard Charlotte)

Overview: The mission of the National Disaster Resilience Council is to inform communities how to mitigate the high-impact threat of long-term power and communications failure (greater than 30 days), which could lead to catastrophic, cascading losses of life-sustaining infrastructures and resources for recovery. Our purpose is to foster communications and coordination to address and mitigate the threat of a simultaneous nationwide or regional collapse of infrastructure from any hazard such as man-made electromagnetic pulse (EMP) or other intentional or naturally occurring hazards.

The NDRC is very concerned about losses of critical infrastructure; of particular concern is the loss of electric power, communications, water & wastewater, food and agriculture, supply chains, associated transportation, healthcare, and information/operation technology (IT/OT). The NDRC is concerned with infrequent hazards and combinations of frequent with infrequent hazards. The intersection of combined hazards experienced during the COVID-19 pandemic has highlighted the importance of the NDRC and its ongoing efforts.

Highlights and Key Activities from 2020 - 2021

• The NDRC committee and its 29 authors wrote the book, Powering Through: Building Critical Infrastructure Resilience, which has received several excellent endorsements. In January 2021, the book was sent to every member of the U.S. 117th Congress thanks to three sponsors: Renewable Energy Aggregators, Nokia, and Hartwell Consulting. The paperback and Kindle versions are available on Amazon.

- 2021 NDRC Summit Produced and held the 2021 NDRC Summit virtually on November 3-4, with nearly 800 people registered. Distinguished speakers and highlights included:
 - + Keynote speaker Dr. George Baker

 - + Senator Gary Peters and Representative Rob Whittman

- The Predictive Modeling Program Working Group is progressing, and we are pleased with the involvement of two electric utility representatives and Dr. Adam Schultz from Oregon State University. - Testing Working Group (Jules LoRusso) making progress on a list of testing establishments who can test for EMP/GMD. They have developed a workflow of how to achieve reliable testing.
- Water Security Working Group A white paper on water security is being developed to highlight the value of water and look at the national security implication of water security. It covers drought, floods, pollution, vulnerable physical structures, cybersecurity, and lack of resources, and provides some key solutions to each of these issues.
- Legislative Working Group (Kate Volandt) reached out to the legislative staff of chairs of key committees and gave presentation.
- Resilience Game Working Group (Mike Carpenter) The game has been announced to the NDRC members. It is an interactive game and a box set is in development. The game with 16 Critical Infrastructure Sectors has been developed.
- Joint Base San Antonio (JBSA) was awarded a special 5G grant and chosen as a pilot project by DOE, DOD, and DHS. Almost weekly, NDRC supports them in a mentoring role, and JBSA greatly appreciates our help.
- Provision of subject matter experts (SMEs) to other organizations NDRC has been supporting JBSA.
 The NDRC provides SMEs to the Department of Homeland Security Cross Sector Coordination for Black Sky Disaster Working Group and DHS Resilient Investment Planning and Development Working Group.
 We reviewed a draft report prepared by DHS for the U.S. Congress on solar storm and man-made EMP hazards and responded to inquiries by U.S. Congressional committee staff and state legislative staff.

InfraGard National Members Alliance Cyber Camp

Chair: Torry Crass

Overview: The InfraGard National Members Alliance Cyber Camp Program ("Cyber Camp in a Box") is designed to provide students with an avenue for positive exposure to cybersecurity to spark new or continued interest in the field, and ultimately lead to careers in cybersecurity and related fields. The Cyber Camp program utilizes resources from within the local IT and security community, local InfraGard chapters, and when available, local FBI field offices, to host a five-day cyber camp program focused on high school students. The program framework provides local InfraGard chapters with guidance and an operational playbook to run an InfraGard National Members Alliance-affiliated cyber camp, while allowing focusing on specific instruction and content most relevant to their local communities. The camp is designed for students between the 9th and 12th grades and provides introductory through intermediate instruction in cybersecurity (and related) fields.

Program Goals

- Foster and encourage an ethical approach to cybersecurity.
- Provide introductory instruction to foster positive interest in cybersecurity.
- Recognize, understand, and use basic computing and security tools at an introductory level.
- Establish an accreditation model for cyber camps hosted across the country.
- Establish and offer additional activities and future opportunities for participating students.

National Highlights and Key Activities from 2020 - 2021

The InfraGard National Members Alliance Cyber Camp Program has encountered substantial headwinds over the last two years due to the impacts of COVID-19. These include the closure of host facilities, a lack of in-person InfraGard chapter events that help with the recruiting staff and volunteers, the cancellation of other summer camp programs, and requirements for social distancing. As we entered 2021, we were optimistic that the 2020 impacts would wane, but 2021 proved to carry the same burdens.

However, we still made significant progress this year.

- The Cyber Camp team stood up a virtualized camp infrastructure, which has been online since spring 2021.

 A Cyber Camp range was built that has been load-tested up to 50 concurrent students (the equivalent of two camps). It is entirely browser-based and running in stable condition with regular maintenance by the team.
- The Cyber Camp team continues to refine lesson plans and the curriculum that will be used in conjunction with the existing range infrastructure. We are creating and adapting content to fit within the structure of this camp and ensure it is interactive and engaging for the students. After all, this is a camp for high school students. It's intended to be fun and spark their interest in technology.
- The goal of the virtualized camp infrastructure and standardization of camp material is to provide a mechanism that will better support cyber camps across the country. This system will lend itself toward an accreditation model for cyber camp programs, which will allow us to approach entities for student opportunities that could include scholarships and internship programs. This path also allows us to be more resilient to the impacts of events such as COVID, leverage expertise in other parts of the country to help with the national program, can reach remote students, allow for all-virtual camps to be conducted, and require less staff to conduct camps. This approach also benefits program governance, ensuring the content and quality of the material presented.

Our Mission: The Revenue Generation Committee is focused on providing the necessary revenue sources for the successful outcome of InfraGard National Members Alliance programs and the successful outcome of our IMAs, with overall objectivity to further our mission of protecting U.S. critical infrastructures and the American people. We achieve that by cultivating sound communications, mutual collaborations and engagement with our FBI, DHS, government, and private sector partners.

Our Goals and Objectives: Design, implement and set levels and benefits of sponsorship opportunities and other fundraising measures to secure donor support and increase revenue for the growth and overall betterment of the INMA and the IMAs. Specifically, the committee's primary revenue source is the Patriots Circle Program, as implemented by Caroline Schirato, Development and Events Director for InfraGard National Members Alliance.

National Highlights and Key Activities from 2020 - 2021

2021 was a challenging but highly successful year for the Revenue Generation Committee, despite the continued impact from COVID-19. To start the new year off with vigor and purpose, the Committee changed its title from Resource Committee to Revenue Generation Committee. A new Charter was developed and approved by the INMA Board of Directors.

- Participation in the Patriots Circle program automatically funnels more money back to the IMAs. The
 additional revenue helps IMAs defray the costs of their more programs and events. Total Patriots Circle
 contributions in 2021 were \$156,500. Of that, a total of \$22,511 went directly back to the IMAs. Since the
 Patriots Circle Program started in June 2019, the total raised to date is \$379,000. The total amount that has
 gone back to the IMAs is over \$48,000.
- 25th Anniversary Sponsorships The Revenue Generation Committee raised \$117,000 in InfraGard 25th Anniversary sponsorships in 2021.
- Funds raised in 2021 supported educational programs and initiatives such as National Infrastructure Security
 and Resilience U (NISRU) and other training programs. Funds were also invested in technology and IT support
 so InfraGard members could attend virtual meetings, webinars, and trainings. Specifically, having IMA
 leaders trained on O365 and Yammer will also increase information-sharing between IMA leaders and their
 members.
- Funds raised in 2021 were also used to support IMA outreach, support and development efforts, including InfraGard Congress, Regional Leadership Conferences, workshops and webinars, financial assistance with directors and officers liability insurance, the annual recertification process, and more.



Pacific Region Overview:

Regional Rep: Bruce Churchill

The Pacific Region IMAs continued active training programs, despite COVID-19 restrictions, by switching to a virtual platform. They discovered that the virtual approach actually increased attendance and member engagement. The Pacific Region is geographically challenged with many chapters covering significant portions of a state (HI, AK, WA, OR, ID, UT, and AZ). Several IMAs became quite proficient in the use of Zoom, GoToMeeting, and GoToWebinar platforms. Many IMAs in the region shared events regionally and nationally. Sector Chief Programs gained traction in the region, including the first IMA-to-IMA mentorship agreement with InfraGard San Diego continuing to actively assist the InfraGard San Francisco Bay Area Sector Program development. InfraGard Southern Nevada also started its Sector Chief Program, which continues to grow.

Fusion Center partnerships continue strong to be in all California IMAs and Arizona, and are being developed in Hawaii and Southern Nevada. Hawaii continues to include Guam and the Northern Mariana Islands in its chapter activities. IMAs in the Pacific Northwest (OR, WA, UT, and ID) are in the process of rebuilding. FBI Idaho support comes from a Resident Agency in Boise and the FBI Salt Lake City Field Office. If there is a Montana chapter, it will also be supported by a resident agency in Helena and the Salt Lake City Field Office. Monthly call regional attendance did not drop below 75% in 2021 and often exceeds 90%. This has been a big plus for information sharing as well as with bootstrapping efforts for rebuilding IMAs.

Chapter Highlights

- InfraGard Arizona The Arizona IMA had the most success in our ability to fully embrace the webinar as the new go-to method for bringing quality content to our members and community. In 2021, we hosted 17 online webinars, the most by far of any year in our history. In addition to our monthly Cyber Threat Brief, we presented topics including domestic violent extremism and malign foreign influence. We also piloted community outreach webinars designed to reach beyond our membership, engage members of the communities, and educate them about InfraGard and the resources available from the FBI.
- InfraGard Hawaii We conducted hybrid meetings to foster critical infrastructure vulnerability awareness among our membership. Our High Intensity Drug Trafficking Area (HIDTA) presentation was well received by the local membership
- InfraGard Los Angeles Using our virtual training platform, InfraGard Los Angeles hosted 34 live training events and 18 additional encore recorded events, providing a combination of commercially prepared, FBI and DHS-hosted trainings to about 11,000 security and law enforcement personnel nationwide. These events included such topics as: FBI Threat Briefings, Counterintelligence trends, Infrastructure Liaison Officer (ILO) training, Maritime Security, Overseas Travel Security, The Threat of Digital Currencies, IED Recognition, SCADA Vulnerabilities, Countering Active Terrorist Cells in the Homeland, a six-part OSINT series, and many more.
- InfraGard San Diego During 2021, we continued to deliver trainings and webinars to nearly 3,000 members and worked with Sector Chiefs to routinely share information with members in their specific sector. We also launched the InfraGard San Diego Cyber Council. We are most proud of our virtual event, Combating the Dark and Wicked World of Crimes Against Children: A Memorial Presentation Honoring Fallen Agents Alfin and Schwartzenberger, co-hosted by InfraGard San Diego and InfraGard San Francisco. This event honored the life's work of these heroic agents and raised over \$27,000 for their families.
- InfraGard San Francisco Our chapter hosted three fireside chats, nine chapter events, and the Silicon Valley Cyber Summit for our members. InfraGard San Francisco also partnered with InfraGard San Diego on a fundraiser for fallen FBI Special Agents Daniel Alfin and Laura Schwartzenberger, raising over \$27,000 for the two families. Kudos to SA Mike Gimbel for working with InfraGard San Diego and the FBI San Diego and Miami Field Offices to make the event a reality. The chapter also launched a Sector Chief Program with active Sector Chiefs for IT, Transportation, Emergency Services, Energy, and Food and Agriculture. Kevin Le and Vik Ghai won INMA's Regional Awards for Rookie of the Year and Meeting the Challenge, respectively.
- InfraGard Southern Nevada 2021 was a year of retooling the board with experienced executives, bringing balance and insight to fuel chapter growth. We met our objective of onboarding seven Sector Chiefs, representing the Defense Industrial Base, Energy, Financial, IT, Transportation, Commercial and Industrial Facilities sectors. Our membership grew 25%, we conducted outreach with the Southern Nevada Fusion Center, and began developing a new web site. These objectives contributed to the InfraGard mission and emphasized interdisciplinary communications among our Sector Chiefs with the objective of implementing efficient information flow with our local FBI partners, Fusion Center and the InfraGard community as a whole.
- InfraGard Washington Evergreen The chapter hosted meaningful webinars focused on critical infrastructure and provided monthly training to all chapter members, taught by subject matter experts.



- InfraGard Iowa After pausing our annual summit in 2020 due to the pandemic, we were able to host it in October 2021. An FBI representative always provides the keynote. This year, it was Special Agent Eric Yingling, and our members were very engaged and asked some great questions.
- InfraGard South Dakota We had record turnout to our quarterly virtual member meetings. Our chapter featured speakers on the topics of detecting ransomware and OSINT tools, which helped our members with continuing education.
- InfraGard Toledo As a rather small IMA, with under 40 active members, getting the group back together and growing was a positive. The board met each and every month during COVID, which was both a goal and an accomplishment. While we have not grown, we have kept our strength and increased our numbers and levels for Patriots Circle. We held two member members (both in-person and virtual) over the course of the 2021 calendar year. Our tabletop exercise and topics were well received.



South Central Region Overview:

Some South Central region chapters began transitioning their meetings to a hybrid online/in-person format in 2021 after initially moving to online meetings in 2020 during the pandemic. Others maintained an online format. Chapters continued sharing online meetings and events both regionally and nationally. After a widespread winter storm early in the year that impacted several states, the region hosted a symposium in April covering best practices in resilience and surviving power grid outages. The region also enjoyed hearing an overview of the Louisiana drone detection program. While our region's chapters held many highly successful and well-attended meetings and events, common challenges in 2021 included finding venues that supported hybrid meetings, gaining new members, and re-engaging members and board leaders.

Chapter Highlights

• InfraGard Birmingham – Our chapter conducted non-IMA outreach and education in three critical sectors. The April CyberNow summit, in partnership with Birmingham's Tech/Professional Organization, drew 700 attendees for a two-day virtual conference featuring four keynotes and 40+ breakouts. 24 of the presenters were IMA members. The October Healthcare Fraud Summit was presented virtually in partnership with eight healthcare executive and professional organization and drew 220 attendees over two days, with 16 presenters, including FBI, USAO, and healthcare attorneys. The November Financial Fraud summit drew 270 attendees over two days for 12 speakers including active and retired FBI, certified fraud examiners, and USAO attorneys. In each case, about 50% of the audience were non-IMA.

- InfraGard Houston InfraGard Houston continued to conduct chapter meetings virtually every other month during the pandemic. Our 14 Cross-Sector Councils (CSCs) conducted their own meetings at least quarterly, with some meeting monthly. Our 2021 chapter meetings covered the topics of public health during the pandemic, a technical deep dive on ransomware, an update on the CIS critical controls, a counterintelligence case study, and lessons learned on cyber threats to industrial infrastructure.
- InfraGard Huntsville A Huntsville member identified an insider threat to the FBI, which was quickly acted on, resulting in neutralization of the threat. It also resulted in a change in policies to prevent or limit a similar occurrence from happening again. This significant event was mitigated due to the InfraGard training, FBI training, and the strong relationship between InfraGard Huntsville and the FBI. The chapter also quickly converted in-person events to virtual events during the pandemic. This allowed us to continue engaging our members in monthly meetings. As the COVID restrictions lessened, we continued the virtual option and retooled our meetings to a hybrid format. This also allowed us to host the monthly National Counterintelligence Task Force Link and Learn sessions using MS Teams.
- InfraGard Louisiana InfraGard Louisiana hosted the NOLASEC Exercise, one of the largest exercises in the state of Louisiana in 2021. The NOLASEC Exercise comprised 210 individuals, representing 129 entities stretching from Lower Mississippi River MM 10 Above Head of Passes (AHOP) in Venice, LA to River MM 260 AHOP in Jackson, LA. Our chapter also hosted the 2021 InfraGard Louisiana North Louisiana Soft Target Workshop from November 30-December 1 in partnership with the Louisiana State Police LA-SAFE and GOHSEP. The workshop drew 80 attendees representing law enforcement and InfraGard members.
- InfraGard Oklahoma Our chapter held continuous meetings throughout the pandemic, with some hybrid meetings, and increased membership despite primarily going virtual. We had nearly 400 in-person attendees for our 14th annual Information Warfare Summit, an all-day conference with several tracks on cybersecurity topics.





Chapter Highlights



- InfraGard Orlando Our chapter has been rebuilding in 2021. A new board was formed and is re-engaging with speakers and seeking sponsors.
- InfraGard Tallahassee Our chapter was able to help educate our members on various important topics through education from guest speakers. A featured event provided members with education about the security of medical devices.
- InfraGard Tampa Bay InfraGard Tampa Bay successfully signed additional sponsors to provide resources to
 promote our objectives. We also participated in regional security summits to meet prospective and current
 members and speakers. We changed 'at large' designations of officers to specifically assign responsibilities
