

NATIONAL SECTOR SECURITY AND RESILIENCY PROGRAM (NSSRP)

The purpose of the National Sector Security and Resilience Program (NSSRP) is to promote interdependent, global, and Internet-reliant critical infrastructure (CI) through the timely, accurate and effective dissemination and exchange of sector and cross-sector specific information. The NSSRP contributes to the InfraGard mission through creation and sustainment of a "network-of-networks" (aka) the sector program. The NSSRP fosters collaboration and information sharing among and between owners, operators, and professionals in each of the 16 critical infrastructure sectors.

Highlights from 2023

In 2023, the National Sector Security and Resilience Program (NSSRP) focused on providing sector-specific training and education to InfraGard members. Utilizing National Infrastructure Security and Resilience U (NISRU), InfraGard National's flagship eLearning platform, National Sector Chiefs presented the following webinars:

April 4, 2023

CYBERSECURITY IS A PATIENT SAFETY ISSUE: A PRESENTATION OF THE HEALTHCARE AND PUBLIC HEALTH SECTOR

This workshop focused on why a healthcare cyber event has more than just financial implications. A thorough review of real-world events illustrated the impacts of a cyber breach on patient care. This workshop also reviewed the implications of artificial intelligence and the Internet of Medical Things.

Presenter Mark P. Jarrett MD, MBA, MS, HCISSP currently serves as Senior Health Advisor for Northwell Health and a Professor of Medicine at the Donald and Barbara Zucker School of Medicine at Hofstra/Northwell. He is INMA's National Sector Chief for the Healthcare and Public Health Sector, and Chair of the Healthcare and Public Health Sector Coordinating Council.

June 22, 2023

RESILIENCE AND CULTURE SINCE 9-11 AND HOW WE CAN SURVIVE IN THE 21ST CENTURY: A PRESENTATION OF THE EMERGENCY SERVICES SECTOR

This webinar provided critical knowledge and tools for supporting and managing the mental health of organizational members, to include providing an understanding of steps to take in developing resilience in mental health management to enhance member safety, health, and engagement. Attendees learned about organizational mindsets and how they must adapt to survive in the future. Lessons learned in the decades since the devastating terror attacks of 9/11, and how they can be applied today, were also covered.

Presenters included:

- Dr. Michael J. Fagel has served fire, rescue, EMS, law enforcement, and corporate risk management for over 45
 years. He teaches bio-defense and homeland security at the Illinois Institute of Technology (IIT) and Northern
 Illinois University.
- Greg Benson, Fire Chief, Port Arthur Fire Department, has served in fire, EMS, and emergency management roles for over 40 years, including services as a firefighter, paramedic and Fire Chief.

National Sector Chiefs presented the following webinars:

July 26, 2023

A PRESENTATION OF THE COMMERCIAL FACILITIES SECTOR

This presentation, given by a third-generation business continuity professional and certified Master Business Continuity Professional, provided an introduction into how to design and implement business continuity training that is engaging and informational for all levels of an organization. Business continuity is a substantial element of any organization's processes, and with younger millennials and Gen Z'ers entering the workforce alongside current longtime professionals, business continuity training must be comprehensive and exciting. This presentation focused on the *who, what, when, where, why, and how* of business continuity. Attendees learned how to engage their workforces in meaningful, bidirectional conversation about recovery and resilience, so all are trained on the BC plan and how to implement it effectively.

Presenter Patrick Hardy is founder & CEO of Hytropy Disaster Management, a full-service small business and family disaster management company. Pat has extensive experience working in the public, private and non-profit sectors in disaster management from micro-businesses to Fortune 500 companies such as Google, Merck, and Parsons Corporations. He is currently the NSSRP National Sector Chief for Commercial Facilities.

June 29, 2023

CURRENT THREATS AND CHALLENGES TO THE DEFENSE INDUSTRIAL BASE SECTOR A PRESENTATION OF THE DEFENSE INDUSTRIAL BASE SECTOR

This webinar provided an overview of the Defense Industrial Base, focusing on current threats, challenges and best practices, particularly around cybersecurity and counterintelligence. Attendees learned about the Defense Industrial Base Sector, its threats and vulnerabilities, and cybersecurity and counterintelligence lessons learned from DIB companies.

- Vince Scott is a retired Navy Cryptologist/Information Warfare Officer and currently serves as the CEO of Defense Cybersecurity Group, a cyber consulting company focused on the DoD Cyber requirements for the Defense Industrial Base. He also serves as the Deputy National Sector Chief of the Defense Industrial Base Sector for InfraGard National members Alliance.
- Chris Gore is President of J2X, a veteran-owned consulting company providing program protection activities for highly classified, research & development projects for the U.S. Government and protecting critical intellectual property for global Fortune 50 companies and small businesses alike.

COUNTERING HUMAN TRAFFICKING AND FORCED LABOR CROSS-SECTOR COUNCIL

Dr. Earl Motzer, Chair

This Countering Human Trafficking and Forced Labor Cross-Sector Council was created in November 2022. Here in the United States, both U.S. residents and foreign nationals are bought and sold like modern-day slaves, according to the FBI. This illegal exploitation of persons causes unimaginable suffering, depriving victims of their freedom, dignity, and basic human rights. The mission of this CSC is to expand the knowledge of InfraGard members about this criminal activity, including ways to recognize possible victims and how to report suspected trafficking activity. Education, briefings, and resources on various aspects of human trafficking and forced labor are provided to InfraGard chapters for their use.

In 2023, the Countering Human Trafficking and Forced Labor CSC held the following educational webinars:

JANUARY 24, 2023

Introduction to the Countering Human Trafficking and Forced Labor Cross-Sector Council (CSC) of InfraGard National Members Alliance

This webinar provided an introduction to the new Countering Human Trafficking and Forced Labor Cross-Sector Council (CSC) of InfraGard National Members Alliance (INMA). Attendees learned how to recognize and report suspected human trafficking and/or forced labor activity and understand the resources available to InfraGard members on this topic.

APRIL 27, 2023

A Presentation of the Countering Human Trafficking and Forced Labor Cross-Sector Council of InfraGard National Members Alliance

Every year, thousands of vulnerable individuals become victims of sexual exploitation and human trafficking. This program featured a panel discussion with survivors and those dedicated to combating this heinous crime. Speakers included: Dr. Earl Motzer – National Board Director and Chair, Countering Human Trafficking and Forced Labor Cross-Sector Council, InfraGard National Members Alliance; Keelin Washington - A live experience expert, advocate, and public speaker in the field of human sex trafficking; Jeff Wohler - President and CEO, San Diego Harbor Police Foundation; and Stephanie Yanta, Senior Account Manager, Intel, NEC National Security Systems.

JULY 25, 2023

Human Trafficking in our Communities: Lived Experiences, Hope and Healing

This presentation featured a female human trafficking victim who was in captivity for fifteen years sharing lived experience, and a male survivor specialist focusing on indicators, legal and medical, social and holistic aspects of human trafficking and how to implement trauma-informed care.

DIGITAL EXHAUST THREATS AND MITIGATION CROSS-SECTOR COUNCIL

The Digital Exhaust Threats (DEX) and Mitigation Cross-Sector Council was established at the end of 2022. This mission of this CSC is to equip InfraGard members, communities, and public/private partners with information, resources, and tools to combat cybercrimes that leverage DEX—from those of convenience (e.g. automated bots) to Advanced Persistent Threats (APTs). Through education, training, and increased awareness of the FBI Digital Exhaust Opt-Out Guide, this CSC aims to increase collective intelligence in this domain, enabling a collaborative defense that contributes to the protection of our nation's critical infrastructure and national preparedness directives.

In 2023, this CSC partnered with the local InfraGard Atlanta Members Alliance to pilot a well-attended webinar titled Introduction to Digital Exhaust.

ELECTRONIC SECURITY INDUSTRY CROSS-SECTOR COUNCIL

The Electronic Security Industry Cross-Sector Council was established to facilitate the gathering, coding, and dissemination of Cross Sector supply chain facility(s) physical and cyber security readiness to the FBI, DHS, and/or other U.S. government agencies charged with maintaining national security, readiness, and resilience.

INSIDER THREAT CROSS-SECTOR COUNCIL

The Insider Threat Mitigation Cross-Sector Council was established to facilitate the identification and mitigation of insider threats faced by all 16 critical infrastructure sectors by organizing communication, education and information sharing of both threat and mitigation information to the leadership of all sectors.

The mission of the Legal Cross-Sector Council is to foster cohesive communication, encourage continuous education, and facilitate efficient sharing of vital threat information among the legal community and associated professionals within the InfraGard membership. By engaging a range of stakeholders, including chairpersons, general counsel, managing partners, assistant general counsel, senior leadership in risk roles, and those collaborating with the legal function, we aim to bolster the resilience and security of our nation's legal infrastructure through collaboration and cooperation.

NATIONAL CROSS-SECTOR COUNCIL PROGRAM (NCSCP)

In 2023, the Legal Industry CSC continued with proactive outreach to its members, including surveys and feedback requests regarding programs, objectives, and more. This CSC is also increasing its focus on legal risk scenarios for all sectors, to include quarterly presentations a recruitment effort to all attorney types that have risk practices, broadening the historical cyber focus into areas such as privacy, workplace risk, threat management, and more.

NATIONAL DISASTER RESILIENCE COUNCIL (NDRC)

Mary Lasky, Chair

The National Disaster Resilience Council's mission is to inform communities how to mitigate the high-impact threat of long-term power and communications failure (greater than 30 days), which could lead to catastrophic, cascading losses of life-sustaining infrastructures and resources for recovery.

In support of this mission, the National Disaster Resilience Council held its annual NDRC Summit on December 5-6, 2023 as a hybrid event, with over 800 people in attendance. The Summit was co-hosted by Joint Base San Antonio (JBSA) and took place at the University of Texas at San Antonio's National Security Collaborative Center (NSCC). The 2023 agenda focused on preparation for adversarial attacks and destructive natural events causing long-term outages of America's critical infrastructure. A powerhouse speaker lineup from government and private industry participated in impactful presentations and thought-provoking panel discussions on five of the hottest topics in infrastructure resilience today: cyber threats; Department of Defense key enablers; operational continuity; research and development updates; and the all-important critical human infrastructure.



The 2nd Annual InfraGard Presidents and PSCs Summit

The 2nd annual InfraGard Presidents and PSCs Summit took place during Congress on Sunday, September 11, 2023. This professional development event underscored the important talents and assets that IMA presidents and FBI Private Sector Coordinators each contribute to the success of the InfraGard Program. A summary of this year's sessions follows below:

Session I: From Need to Success: A Case Study of Joint FBI-IMA Efforts in Agriculture

Local events are the cornerstone of the InfraGard program, bringing IMAs and local FBI Field Offices together to address the top threats in their AOR. Our presenters will highlight a highly successful joint event – from identifying the need to determining the format, speakers and logistics – so other InfraGard chapters can replicate similar events in their regions. The Agriculture Sector generates \$47.4 billion annually in Iowa and Nebraska alone, presenting significant vulnerability to threat activity. The FBI and Nebraska IMA hosted an Agricultural Threats Symposium in June 2023, which brought together 350 government, private sector, academic, and law enforcement partners to discuss the threats and how to share information.

ACTIVE SHOOTER PROGRAM:

A Collaboration of InfraGard National Members Alliance and the FBI Office of Private Sector

In October and November 2023, InfraGard National and the FBI Office of Private Sector collaborated to present the Active Shooter Program. One of the many benefits of being an InfraGard member is receiving information and education on timely threats. As concerns about targeted violence quickly escalated at the beginning of the Israel-Hamas War, we co-hosted a special presentation on active shooter incidents in the United States, with a focus on houses of worship.

InfraGard members were also given the opportunity to invite non-members, such as security personnel at their houses of worship and their children's schools, further providing a public service to communities when it was

needed the most.

THE ACTIVE SHOOTER PROGRAM **SERVED OVER 1,600 INFRAGARD** MEMBERS IN THE SPAN OF JUST TWO WEEKS, PROVIDING THEM WITH KNOWLEDGE AND RESOURCES FOR PREVENTION, PREPAREDNESS, AND AN ACTUAL ACTIVE SHOOTER EVENT.

ACTIVE SHOOTER PROGRAM: HISTORY, INCIDENTS AT HOUSES OF WORSHIP, AND STRATEGIES FOR PREVENTION AND **PREPAREDNESS**

InfraGard National and the FBI Office of Private Sector's joint presentation on Active Shooter incidents in the United States focused on incidents and lessons learned pertaining to houses of worship. A portion of the presentation emphasized prevention and preparedness using the options of

Run, Hide, Fight to develop plans that empower individuals who are faced with these situations. Specifically, it was recommended that individuals develop situational awareness for any environment so they may react and respond in a manner to try and stay safe.

The featured presenter was John P. Skillestad, a Supervisory Special Agent assigned to the Office of Partner Engagement at FBI Headquarters, Violence Reduction Unit, where he serves as the Program Manager for the Active Shooter Program. In this role, SSA Skillestad oversees the annual Active Shooter Study and provides training regarding Active Shooter planning, preparedness, response, and recovery to law enforcement personnel, first responders, military personnel, educators, businesses, healthcare workers, houses of worship, and community leaders.

"Our amazing board of directors here in Alaska has been busy this past year focusing on the InfraGard mission, primarily through holding consistent member meetings, creating an after-hours event, attending local conferences and trade shows, and slowly re-establishing member engagement and building value.

In 2023, we also took on an Elder Fraud initiative that sought to increase awareness of this important issue which is impacting our communities. In 2022, Alaskan elders age 60 and over lost over \$7 million to scammers. Through presentations given at local organizations - ranging from senior centers to Chambers of Commerce and Rotary Clubs - we were able to educate seniors on the common schemes being used, reduce the stigma associated with victimization, encourage reporting, and even assist several victims in submitting IC3 reports to our FBI partners.

A unique partnership with Walmart also allowed us to add 2,000 Elder Fraud flyers to "bush orders" being shipped out to remote Alaskan communities and host information booths at their Fairbanks and Wasilla stores. I'm really proud of the way InfraGard Alaska has stepped up to address this threat to the American people and expand our vision beyond just the cyber realm."

"On June 6-7, 2023, FBI Omaha and the Nebraska InfraGard Nebraska Members Alliance hosted the inaugural Agriculture Threats Symposium at the Nebraska Innovation Center in Lincoln, Nebraska. Approximately 350 individuals from 16 states representing over 150 unique entities attended the Symposium in person.

This Symposium brought together attendees from academia, private sector, law enforcement, and government to share information on threats to the Agriculture Sector, driving home the point that agricultural security is national security. This event was the first of its kind to bring these partners together to discuss agricultural security, and led to follow-on engagements with law enforcement, government, and community groups that resulted in over 1,000 people becoming more aware of the threats that American farmers and ranchers face.

Media coverage of the event, which featured remarks by the Nebraska Governor, Nebraska Attorney General, President of the Nebraska Farm Bureau, and FBI Assistant Director for Intelligence, expanded engagement further. Through this venue, both the InfraGard Nebraska Members Alliance and InfraGard Iowa Members Alliance chapters hosted a table to engage attendees and increase InfraGard membership. Following on this success, FBI Omaha and the InfraGard Nebraska Members Alliance will host a second Agriculture Threats Symposium on August 12, 2024 in Omaha, Nebraska."
